Registration Deadline: Applications are accepted on a first received/first paid basis. To guarantee listing in the event signs, registration, insurance certificate, and payment must be received by **March 1st, 2017**.

Promotions & Amenities:

- Email touchatruckmidland@gmail.com with any needs or questions, and we will try to accommodate them. (ex.. electricity, space, location)
- Participants may give away promotional items appropriate for children.
- Participants may bring banners, signage, decorations, etc. to promote their business based on sponsor level. Fences or poles upon which to hang signage cannot be guaranteed. Participant should bring their own supports for banners or signs. MOMS Club of Midland shall not be held responsible for any loss or damage to any participant property and shall not be responsible for any damage (property or bodily injury related) caused by said participant property.

Participation Guidelines:

- Participant space assignments will be determined by the TAT Midland team, based upon the best interests of the event and/or first-come-first served basis. Space will be located in the parking lot of Security Bank Ballpark-Rockhounds Stadium. **A representative will contact you with your zone and delivery time, location and map.** When you arrive see ladies in hard hats or call Kari. 512-787-9110
- Sponsors must provide a minimum of one (1) adult representative during the event to supervise their station between the hours of 12:00 pm to 5:00 pm on Saturday, May 6, 2017. Vehicle representative(s) should be able to provide a narrative description of the vehicle's specifications and/or services.
- The nature of the Touch a Truck event involves the interaction of children with Participant's vehicle(s) so that the children are able to touch, see, and explore the participant's vehicle(s) and learn about the vehicle(s)'s function. MOMS Club of Midland and the TAT team will take appropriate measures to facilitate a safe event; however, the Participant is responsible for the supervision and safety of its property. The Participant shall defend, indemnify, save, and hold harmless The Touch a Truck team and MOMS Club of Midland and its volunteers from any and all liability, damage, loss, claims, cost demands, and actions of any nature whatsoever arising out of the Touch a Truck event.
- Participants with vehicles agree to provide a Certificate of Liability Insurance containing the following minimum requirements: General Liability Limits of One (1) Million Dollars Per Occurrence, Automobile Liability Limits of One (1) Million Dollars, and **Naming of MOMS club of Midland as an Additional Insured on said policy of insurance.**
- Participants with vehicles must arrive on the event day (May 6, 2017) between 6:00 am and 10:00 am to set-up. Vehicles requiring special accommodations, such as a large turning radius, will be asked to arrive early during event set-up. Participants with vehicles must stay the entire length of the event and may not leave until the event's conclusion at 5:00 pm unless otherwise agreed to in advance by the Touch a Truck planing Team.
- Participants grant permission to MOMS Club of Midland to take photographs or record videos of participant and/or display during the event for the strict purpose of promotion and publicity of the event and/or our organization.
- Participants and their representatives shall conduct themselves in a manner that is appropriate for the family-oriented event, which includes but is not limited to the following restrictions: No smoking, no profanity, and no display of inappropriate content or clothing. In the event of inappropriate behavior at the event, the Touch a Truck team reserves the right to close the participant's booth, and all Sponsor fees paid to MOMS Club of Midland will be forfeited.
